## 1 FIND A PARTICIPATING CONTRACTOR

## 2 SCHEDULE AND COMPLETE A HOME ENERGY ASSESSMENT

During your appointment, a Participating Contractor will evaluate your home's efficiency and give you a detailed report with recommendations for just \$100\* (a \$400 value).

Your appointment includes:

- A **consultation** where you can share any concerns you may have about your home's energy use and comfort, such as issues with moisture, indoor air quality, drafts, mold, or excessive dust.
- An **assessment** of your home including the living space, attic, crawl space/basement, and exterior. With advanced diagnostic equipment like a blower door and thermographic camera, your contractor will conduct tests to identify and prioritize energy efficiency opportunities in your home.
- The **installation of energy-efficient products** such as LED bulbs, smart power strips, and more—at no additional cost. You'll start saving energy and money right away.

## 3 REVIEW RECOMMENDATIONS AND RESERVE REBATES

Following your assessment, you'll receive a customized report with recommendations and rebate amounts for specific home improvements you can make to maximize your savings and comfort.

When you decide which energy-saving upgrades to make, your Participating Contractor will reserve your rebates up to \$7,500. For your upgrades to be eligible, your contractor must install all improvements within 60 days of approval.

## 4 INSTALL ENERGY-SAVING IMPROVEMENTS

Installation of your energy efficiency upgrades may take multiple days to complete. Meet your contractor at the beginning of each day before work starts and review progress at the end of each day.

After your upgrades are installed, you'll receive:

- A **final test of your home's efficiency** to ensure the work was done properly and there are no air quality or safety issues.
- A **Job Completion Form** to document the final test and inspection.
- A **rebate check** in 6–8 weeks from the date your completed application is received. Your contractor is responsible for submitting all required documentation within 30 days of installation.
